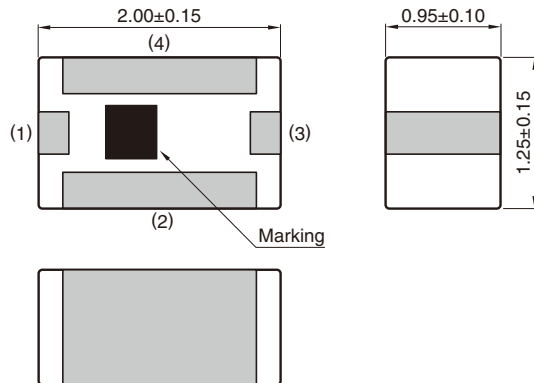

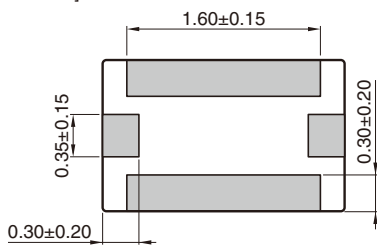

[Bottom view]

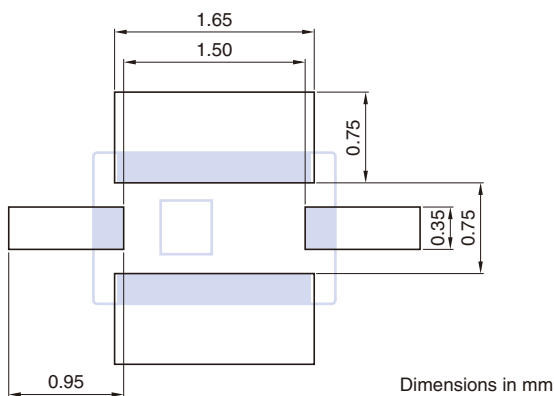

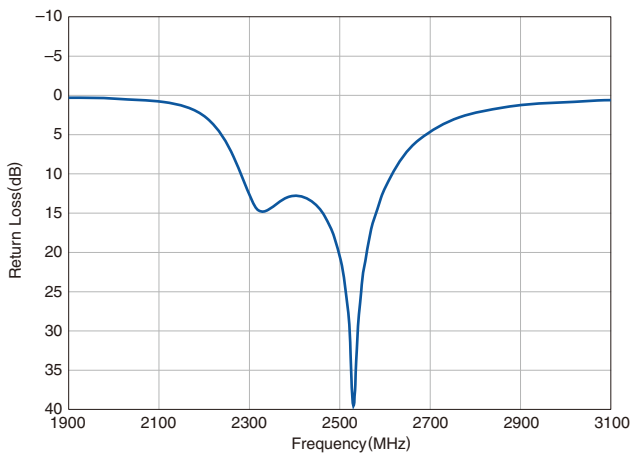
## INSERTION LOSS



## ATTENUATION

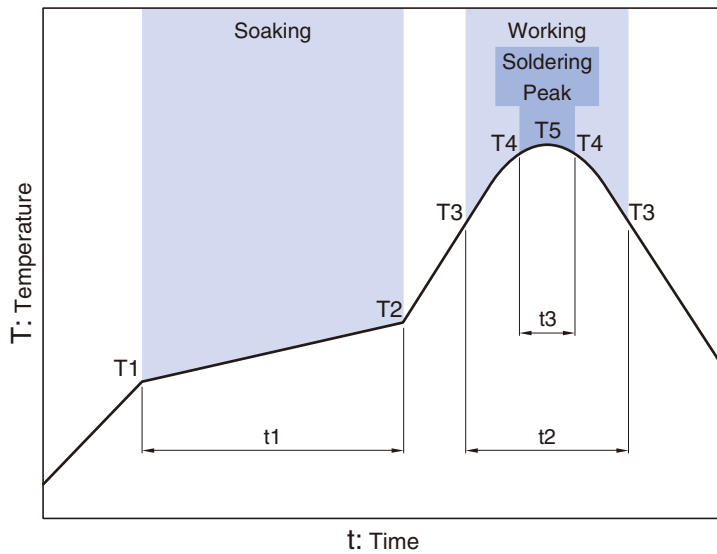
